We/I hereby make applications for the three (3) days rental of ____ 10 foot Art and Craft boutique areas as outlined in my application attached to this contract.

**A limited number of spaces are available.
ONLY ONE AREA PER CONTRACT, NO EXCEPTIONS!**

We/I hereby agree to abide by the following conditions:

1. Presque Isle Partnership shall not be responsible for any injury or loss that may arise or come to the lessee or his/her employees or his/her goods from any cause whatsoever while said rental areas are occupied under this agreement.
2. The exhibitor agrees to remove from display all articles or signs objectionable to the Presque Isle Partnership
3. To be considered for the Juried Art and Handcrafts Show, you must provide us with two photos and a brief description of your craft. The absence of the required material automatically results in the rejection of your application.
4. Exhibitors must have a valid PA STATE SALES TAX LICENSE on the opening day of the show in order for this contract to be valid.
5. **No exhibit is to be removed, or packing to commence, until after the close of the show.**
6. No raffles are to be sold.
7. No commercially made items are permitted in the Arts and Crafts areas. A commercial/resale area is provided for this type of exhibit. **Any exhibitor found to violate this condition will be moved to the resale area or asked to leave the show without any refund of the fees paid.**
8. Only your **HANDCRAFTED/HANDMADE** items are to be displayed within the Arts and Craft area. If items not fitting this description, within the sole judgment of Presque Isle Partnership, are found within your display such items will be required to be removed immediately.
9. It is understood that Presque Isle Partnership provides NO TABLES to exhibitors in the show.
10. Vehicles must be parked only in the area that the show coordinators designate.
11. **No exhibit areas are to be moved/switched or rearranged by anyone other than the event coordinator.**
12. **All spaces must be packed up by 5:30pm on Sunday in order to complete the cleaning of the waterworks area.**
